The Tire Industry Project reserves the right to unilaterally change these Terms and Conditions, at its sole discretion at any time and without prior notice, whenever it deems necessary.

Registration for the 2026 Tire Emissions Research Conference

All registrations for the 2026 Tire Emissions Research Conference must be processed online through the conference website: [Registration - Tire Industry Project](#), clicking on the “Registration” button and following the provided instructions. Specific information may be requested during the registration process for individuals and group registrations. Upon completion of your online registration, you will be sent an acknowledgement email as well as an invoice to the email address you provided on the registration form.

Registration fees

Registration fees may vary depending on the date you register, as indicated by the registration categories and deadlines on the registration website. All registration fees are in Great British Pounds (GBP) and are exempt from VAT.

Should you process your registration via a bank transfer, please make sure the processed amount matches the total fees for your registration in GBP.

Registrations are only confirmed once the required payment has been received. You will receive a confirmation email from the registration team upon receipt of the payment.

Cancellation policy

In case you wish to fully cancel your conference registration, the Conference Secretariat must be notified **in writing by sending an e-mail to** TireEmissionsResearchConference@wearemci.com.

The following cancellation conditions apply:

- In case of cancellations received **before or on 31 August 2026**, the registration fee will be refunded with a deduction of £45, shown as administration charge.
- In case of cancellations received **after 31 August 2026** or no-shows, the registration fee will not be refunded.

Any refunds due will be processed within 30 days after the conference dates.
